WKUCCC operates a combination Early Head Start, Head Start and Non-Profit Child Care Program for children six weeks through five years of age. WKUCCC is a unit of Training & Technical Assistance Services (T/TAS), a department in the College of Education & Behavioral Sciences

Program Philosophy

The WKUCCC philosophy is based on the premise that all children share needs and that children benefit from a comprehensive developmental program to meet those needs. The WKUCCC program maximizes the strengths and unique experiences of each child. The family, the principle influence in the child's developmental, is invited to be a direct participant in all aspects of the center

Approach

WKUCCC offers an educational program that utilizes an individualized, child-centered, problem-solving approach to learning. Children are encouraged to learn through play, exploration, experimentation and active involvement. WKUCCC utilizes the Creative Curriculum for infants, toddlers and preschool children. WKUCCC offers experienced, well-trained staff, low child-teacher ratio, developmental and health screenings. To inspire children and families to strive to their fullest potential every day.



Program Goals

Goal 1: To provide three and four year old preschool children and their families comprehensive services that will foster children's development competence in all learning areas to support the foundation for school readiness during the early years

Goal 2: To ensure all families have access to a support system designed that provides children and their families with appropriate health, oral health, nutrition and mental health.

Goal 3: Parent, Family and Community Engagement (PFCE): To increase the number of families who participate in the Family Partnership Agreement (FPA) process and to seek new community partners with focus on advocating for children's academic success.

Goal 4: Program Design and Management: To ensure comprehensive services are provided by maintaining efficient data systems and assure systems are in place and properly maintained.

Kentucky ALL STARS

Western Kentucky University Campus Child Care is currently a three star program. We are happy to announce the program is working toward earning five stars.

Kentucky All STARS recognizes and supports quality early care and education programs.

On the expanded five-star scale, STARS level one is obtained by meeting regulatory requirements. STARS level two is obtained by completing a set of required domains and standards. STARS levels three through five feature a range of points programs must meet in order to move up on the rating scale. While there are required domains for these three STARS levels, programs can choose from a menu of standards to fulfill the requirements.





Federal Monitoring Including Financial Audit

In March of 2023 Head Start and Early Head Start had a Focus Area 2 Monitoring Review conducted by the Administration for Children and Families. There were no areas of concern, areas of noncompliance, or areas of deficiency.

CLASS Scores

WKU CCC uses the Classroom Assessment Scoring System (CLASS) as an observational instrument to assess our preschool classrooms on an annual basis. CLASS is a valid and reliable research-based observational instrument. CLASS measures and assesses the quality of teacher-child engagements across the areas of: (1) Emotional Support; (2) Classroom Organization; and, (3) Instructional Support which are linked to positive child outcomes and later achievement.



Professional Development

Comprehensive training equips teachers with the knowledge and skills needed to create developmentally appropriate environments, identify signs of developmental delays, and effectively manage classrooms. It empowers educators to navigate the complexities of early childhood with confidence.



ChildPlus Software

WKU CCC uses ChildPlus Software to manage data. ChildPlus supports data based decision making ensuring the needs of the children and families served are addressed in a meaningful manner.



Foster Grandparents

WKU CCC is also involved in the Foster Grandparents Program. This is a program that provides senior volunteers, ages 55 and older, an opportunity to support, encourage, mentor, and nurture children. Foster Grandparent volunteers, the children they serve, the teachers, the classrooms, and our communities all benefit from the program. Children of all ages can improve with the interaction, support, attention, and wisdom provided by Foster Grandparent volunteers.



Volunteers

Volunteers are critical to the success of our program. The participation of volunteers has been an effective way of mobilizing community resources to strengthen our Services. Volunteers provide a wide range of services. Volunteers can be professionals and nonprofessionals, parents, local residents, and members of the larger community, board members and those who serve on policy and advisory groups, those who work in classrooms, offices, or kitchens, and those who provide necessary health education, medical and dental examinations, and other health services. Head Start volunteers can assist with classroom activities, upkeep and renovation of centers, playground supervision, parent education, and other similar tasks. Head

Start volunteers may choose to give a few hours of time, or may

volunteer every week.



ReadyRosie Parent Curriculum



ReadyRosie, an evidence-informed, research-based family engagement resource and parenting curriculum that has been shown to have positive impacts on family behaviors and child outcomes. This curriculum is an online resource that emails daily activities to adults to do with their children ages 0-5. Each activity is modeled with a two minute video. The activities are simple, take about two minutes, and help prepare children for school building off the foundation set in the belief that parents are their children's first and most important teacher.



Kentucky Head Start Association

National Head Start Association

Policy Council

Head Start programs are required to establish and maintain a formal structure of shared governance allowing parents the opportunity to participate in policy making and other decisions regarding the program. This is accomplished by providing parents with two different opportunities.

- 1) Parent Meetings These meetings give parents an opportunity to have a voice in local center decisions.
- Policy Council Meetings Parents are elected from the parent meetings to act as an advocate for the parents ensuring their voices are not only heard but considered in decision making.
