ACADEMIC PROGRAM SUSPENSION

REQUEST: Approval for academic program suspension for the following program: Floristry, Minor.

<u>FACTS</u>: The Faculty made the decision to suspend the Floristry minor based on the recommendation of the Comprehensive Academic Program Evaluation (CAPE) process and instead focus resources on an undergraduate certificate. The Floristry certificate was implemented in Fall 2021.

<u>BUDGETARY IMPLICATIONS</u>: Closing this academic program to new admissions will have no impact on the University Budget because the faculty will continue to offer courses in the floristry undergraduate certificate.

RECOMMENDATION & IMPLEMENTATION DATE: President Timothy C. Caboni recommends approval of the suspension of the Floristry Minor to be implemented Fall 2024.

MOTION: Approval to suspend the following program: Floristry, Minor with implementation in Fall 2024.

ACADEMIC PROGRAM SUSPENSION

REQUEST: Approval for academic program suspension for the following program: **Master of Science** in Child and Family Studies.

FACTS: Enrollment in the Child and Family Studies graduate program has been slowly declining over the past four years. The number of enrolled students decreased from 17 in 2018 to 7 in 2022. Although the annual degrees awarded have been fairly consistent between 4 and 7, they are trending downward, and the enrollment decline is steady. One factor contributing to this decline is the overall decrease in students studying child and family studies at the graduate level. Additionally, we have had two graduate faculty retire. Furthermore, after an initial period of incoming extension agents and others waiting for our online graduate program to launch in 2017, the pool of available applicants has decreased. The novelty of our online graduate program has waned, as other programs both inside and outside of Kentucky are now offering online graduate degrees in our field.

With the renewed emphasis on efficiency, the program faculty decided to focus on enhancing and growing our undergraduate program and so would like to close the Master of Science in Child and Family Studies and all delivery methods to new admissions beginning January 15, 2024. Suspending the graduate program allows graduate faculty to reassign their time and effort in our undergraduate program.

BUDGETARY IMPLICATIONS: Closing this academic program to new admissions will have minimal impact on the University Budget because the faculty will continue to offer courses in the undergraduate program.

RECOMMENDATION & IMPLEMENTATION DATE: President Timothy C. Caboni recommends approval of the suspension of the Master of Science in Child and Family Studies to be implemented Spring 2024.

MOTION: Approval to suspend the following program: Master of Science in Child and Family Studies with implementation in Spring 2024.
