The Potter College of Arts and Letters; the Ogden College of Science and Engineering; the Gordon Ford College of Business; the College of Education and Behavioral Sciences; the College of Health and Human Services; and the University College select an award winner in each area. University Libraries selects awardees in research/creative activity and public service only. See Policy 1.118V on the Academic Affairs Policies page.

University-wide award winners are chosen from among the college awardees by student/faculty/alumni committees chaired by the Vice Provost. Award winners receive a University gift and cash stipend.

Revision:

X.A. Faculty Awards:

The University annually recognizes <u>various university- and college-level awards for full-time and part-time faculty, and outlines the procedures for nomination, selection, and recognition. outstanding faculty achievement in the areas of teaching, research/creative activity, advising, and public service. The Potter College of Arts and Letters; the Ogden College of Science and Engineering; the Gordon Ford College of Business; the College of Education and Behavioral Sciences; the College of Health and Human Services; and the University College select an award winner in each area. University Libraries selects awardees in research/creative activity and public service only. See Policy</u>
