Resolution 2-17-F. Resolution to Support the endorsement of a Clean DREAM Act

PURPOSE: For the Student Government Association of Western Kentucky University to support the Congress of the United States of America in passing a Clean DREAM Act

WHEREAS: The Deferred Action for Childhood Arrivals (DACA) program which provided temporary protection from deportation for hundreds of thousands of young people who were brought to the United States as children has been rescinded as of September 5th, 2017,

WHEREAS: A clean DREAM act is necessary for these young people (Dreamers) to obtain a more permanent immigration status. The clean DREAM act would allow for the adjustment of status of many of our current and past students (Dreamers) who may otherwise be without immigration status and at threat for removal from the school, and the country, if Congress fails to act within 6 months from the date DACA was rescinded and

WHEREAS: A clean DREAM act would also include the parents and families (Original Dreamers) of students so they may adjust their status. This is necessary because keeping student's families together assures their academic success and
