- 1.7 Course description: Specifically designed for teachers and other educators, course focuses on the identification and evaluation of specific environmental issues, leading to possible environmental/service action projects by their students, with attention to the potential outcomes of such projects on the physical environment, other humans, and other living things.

#### 2. Rationale

- 2.1 Reason for developing the proposed course: Since the environmental education endorsement for teachers was approved as an optional addition to a teacher's professional certificate, the national standards for environmental education have been updated and approved by the National Council for the Accreditation of Teacher Education (NCATE). The new standards put more emphasis on providing teachers with instruction on how to effectively involve their students with the identification and evaluation of specific environmental issues, leading to possible environmental/service action projects by their students. In addition, because of the way that this course will connect environmental education with service learning, it correlates strongly with the university mission related to student engagement.
- 2.2 Projected course enrollment: 25 per offering. Students enrolled in the environmental education endorsement will be the main audience for the course. However, the course will also be open students from other graduate programs that want their students to be able to teach others how to investigate and evaluate environmental issues in an educational context.
- 2.3 Relationship of the proposed course to courses now offered by the department: This course will enhance the other courses now offered as part of the endorsement in environmental education. ENVE 520 is an introduction to the field of environmental education. ENVE 580 deals with general instructional strategies in the field. This proposed course specifically relates to an educational approach to investigating environmental issues, which meets the new national environmental

- education standards. No other course in the department combines environmental education and service learning.
- 2.4 Relationship of the proposed course to courses offered in other departments: The Department of Public Health offers PH 560, Environmental Management and Risk Assessment, which is part of the Environmental Health Option. The Department of Geography and Geology also offers GEOG 571, Quality of Life: Environmental Problems and Ecological Solution. Although these courses do look at the relationship between the presence of adverse environmental conditions and their potential impact on human health, neither was developed for teachers. The proposed course focuses on how teachers can guide their students into investigating and evaluating environmental issues, resulting in student projects which deal with local environmental problems. In addition, the proposed course content is correlated with the Kentucky Teacher Standards and the National Environmental Education Standards.
- 2.5 Relationship of the proposed course to those offered at other institutions: The proposed course is similar to courses offered by Eastern Kentucky University (CNM 800 Environmental Issues for Teachers), Northern Kentucky University (ENV 578 Environmental Issues for Teachers), and the University of Wisconsin-Stevens Point (NRES 870 Environmental Issue Investigation and Action).

- Identify and analyze relevant public and private policies and community practices. Examine who makes policy and how. Understand different perspectives on the issue.
- Identify possible project options for affecting change in policy or practice in school or community, and select one.
- Guide students in the development and implementation of the plan of action (i.e. environmental service learning project) for the class to undertake.
- Assess the project and the process. Identify any next steps for addressing the problem.

The added class will deliver instruction on the needs of diverse learners including gifted and talented learners, students with varying disabilities, and individuals having culturally diverse backgrounds.

The deletion of MGE 275 will remove the redundancies that exist in the B&M Ed. program between this class and EDU 250. This removal will also facilitate the effective transition of students from a AS KCTCS program into the BS B& M Ed. program at WKU. A viable substitution for EDU 250 is offered at KCTCS institutions. Currently faculty in the B&M

Ed. program are developing a 2+2 articulation agreement between WKU and KCTCS. Further, the removal of MGE 275 will keep the number of hours in the program at the current number.

- Applicants with undergraduate degrees in elementary education from all other accredited universities will be admitted without a qualifying GRE score if they have a minimum 2.75 GPA for all previous coursework (undergraduate and graduate) and a valid teaching certificate for elementary grades. A copy of the certificate must be submitted with the application.
- Applicants from all other accredited universities with a GPA lower than 2.75 (undergraduate and graduate) must achieve a GAP (GRE score multiplied by the undergraduate GPA) score of 2200 or higher and a GRE

Analytical Writing score of 3.5 or higher, and they must have a valid teaching certificate for elementary grades. A copy of the certificate must be submitted with the application.

All applicants to the MAE program in Elementary Education must:

- A modification of admission requirements is proposed. Because of the exit requirements (Critical Performances and the Teacher Work Sample, in particular) for students who complete the B.S. in Elementary Education at WKU, the faculty believe that WKU alumni should have the skills to be successful in the MAE in Elementary Education; thus, no GRE scores are necessary. Students with undergraduate degrees from other institutions will be required to have qualifying GAP and GRE writing scores unless they have at least a 2.75 GPA; this is based on observations that the undergraduate GPA may be a better predictor of success in this program than GRE scores. A pilot program in Fall 08 suggested that there was no difference in course grades or in overall pass rates on course critical performances for students admitted without qualifying GAP and GRE writing scores, compared to those admitted Fall 07. A second reason for providing alternative admission criteria is to remain competitive with other institutions that do not require GRE scores for all applicants.

- A course in health education is no longer required by the Educational Professional Standards Board (EPSB) for Middle Grades Teacher Certification. The PH 100 Personal Health course is being deleted as a specific requirement for the Middle Grades Education program to allow for a smoother transition for students transferring to WKU or changing their major to the Middle Grades Education Program.
- Faculty reviewed the content of COMM 145- Fundamentals of Public Speaking and COMM 161- Business and Professional Speaking and determined both are appropriate courses to fill the criteria.
- The Mathematics Department revised the courses in mathematics for the Elementary and Middle Grades Education programs changing Math 211- Mathematics for Elementary Teachers I to Math 205- Number Systems and Number Theory for Teachers.
- The Mathematics Department revised the courses in mathematics for the Elementary and Middle Grades Education programs changing Math 212- Mathematics from Elementary Teachers II to MATH 206- Fundamentals of Geometry for Teachers.
- MATH 308- Rational Numbers and Data Analysis for Teachers is an approved course added by the mathematics department.
- BIOL 122/123- Biological Concepts Evolution, Diversity and Ecology/Lab has recently become a prerequisite to BIOL 222/223- Plant Biology and Diversity/Lab and BIOL 224/225- Animal Biology and Diversity/Lab. BIOL 122/123 provides significantly better program of studies and Core Content coverage than the current BIOL 223/224 or BIOL 224/225 requirement.
- The improved content coverage of BIOL 122/123- Biological Concepts Evolution, Diversity and Ecology/Lab makes the current BIOL 398- Cooperative Education in Biology II or BIOL 475- Selected Topics in Biology requirement redundant.
- The addition of ASTR 104- Astronomy of the Solar System or ASTR 106- Astronomy of Stellar Systems or ASTR 108- Descriptive Astronomy or ASTR 214- General Astronomy is due to these courses becoming prerequisites for ASTR 405- Astronomy for Teachers.
- The addition of ASTR 108- Descriptive Astronomy or ASTR 214- General Astronomy as options to ASTR 104- Astronomy of the Solar System or ASTR 106- Astronomy of Stellar Systems or ASTR 405- Astronomy for Teachers is to provide consistency in course options in the single and dual area programs.
- Faculty reviewed the requirements for the Middle Grades Praxis II exam in Social Studies and determined that ECON 150- Introduction to Economics meets the required content. However, KCTCS at Elizabethtown does not offer the equivalent to ECON 150 and the alternative is ECON 202- Principles of Economics (Micro) or ECON 203-Principles of Economics (Macro)
- Clarification to include new appropriate courses for social studies electives in the future.

- 9. achieved critical performance assessment scores that average at least 3.0 overall and at least 2.5 per Kentucky Teacher Standard measured.

- 11. demonstrated moral, social, and ethical behavior that is acceptable in the school community and the community at large.
