



# Allen , Kentucky

Personal income last published on November 16, 2021.

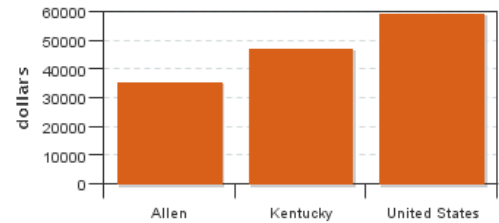
Allen is one of 120 counties in Kentucky. It is part of the Bowling Green, KY Metropolitan Statistical Area. Its 2020 population of 21,303 ranked 53rd in the state.

**Note:** 2020 population estimates do not incorporate the results of the 2020 Census. BEA will incorporate the Census Bureau's population estimates based on the 2020 Census results when they become available.

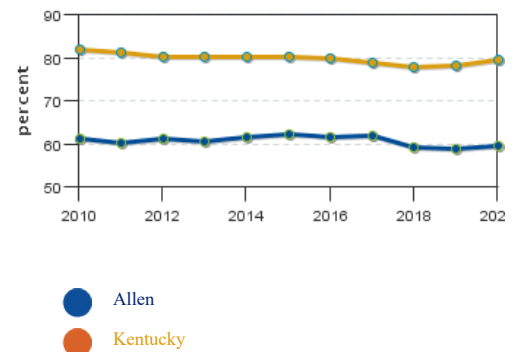
## Per Capita Personal Income

In 2020, Allen had a per capita personal income (PCPI) of \$35,499. This PCPI ranked 107th in the state and was 75 percent of the state average, \$47,339, and 60 percent of the national average, \$59,510. The 2020 PCPI reflected an increase of 7.5 percent from 2019. The 2019-2020 state change was 7.9 percent and the national change was 6.2 percent. In 2010, the PCPI of Allen was \$24,906 and ranked 101st in the state. The 2010-2020 compound annual growth rate of PCPI was 3.6 percent. The compound annual growth rate for the state was 3.5 percent and for the nation was 3.9 percent.

## Personal Income

In 2020, Allen had a personal income of \$756,243\*. This personal income ranked 61st in the state and accounted for 0.4 percent of the state total. In 2010, the personal income of Allen was \$498,696\* and ranked 63rd in the state.

## Components of Personal Income

Personal income includes net earnings by place of residence; dividends, interest, and rent; and personal current transfer receipts received by the residents of Allen.

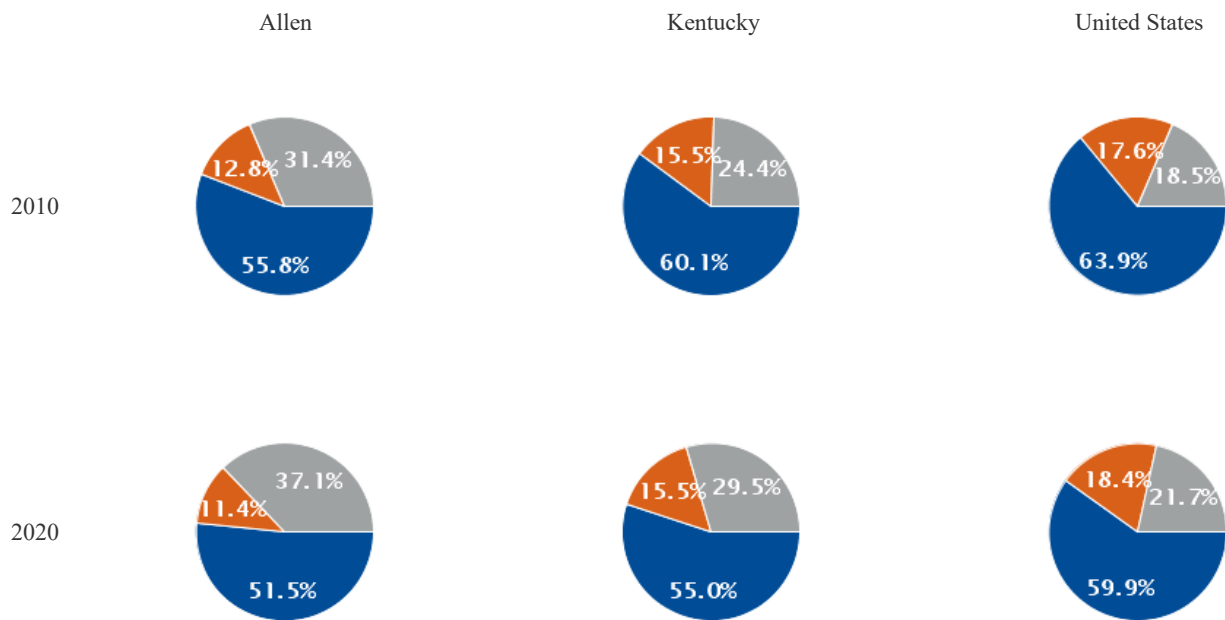

## Gross Domestic Product (GDP) by Local Area

In 2019, Allen produced \$505,513 in [current-dollar total GDP](#)<sup>\*</sup>. This GDP ranked 62nd in the state and accounted for 0.2 percent of the state total. In 2009, the total GDP of Allen was \$326,238 and ranked 70th in the state.

In 2019, Allen real GDP grew 0.1 percent; the 2018-2019 state change was 1.8 percent. The 2009-2019 compound annual growth rate for Allen real GDP was 3.2 percent; the compound annual growth rate for the state was 1.4 percent.

## Industry Composition

Goods- and services-producing industries and government comprise total GDP. Industry statistics reflect the value of goods and services produced by each of those industries located in Allen. In 2019, services-producing industries produced the largest portion of GDP, while goods-producing industries and government produced the second and third largest portion of GDP, respectively.
