

# Logan, Kentucky

### Personal income last published on November 16, 2021.


Logan is one of 120 counties in Kentucky. It is not part of a metropolitan area. Its 2020 population of 27,416 ranked 38th in the state.

**Note:** 2020 population estimates do not incorporate the results of the 2020 Census. BEA will incorporate the Census Bureau's population estimates based on the 2020 Census results when they become available.


## Per Capita Personal Income

In 2020, Logan had a per capita personal income (PCPI) of \$40,963. This PCPI ranked 57th in the state and was 87 percent of the state average, \$47,339, and 69 percent of the national average, \$59,510. The 2020 PCPI reflected an increase of 10.5 percent from 2019. The 2019-2020 state change was 7.9 percent and the national change was 6.2 percent. In 2010, the PCPI of Logan was \$28,938 and ranked 59th in the state. The 2010-2020 compound annual growth rate of PCPI was 3.5 percent. The compound annual growth rate for the state was 3.5 percent and for the nation was 3.9 percent.

Personal Income

In 2020, Logan had a personal income of \$1,123,055\*. This personal income ranked 37th in the state and accounted for 0.5 percent of the state total. In 2010, the personal income of Logan was \$777,096\* and ranked 40th in the state.

# Gross Domestic Product (GDP) by Local Area

In 2019, Logan produced \$1,189,436 in current-dollar total GDP\*. This GDP ranked 34th in the state and accounted for 0.6 percent of the state total. In 2009, the total GDP of Logan was \$712,571 and ranked 43rd in the state.

In 2019, Logan real GDP grew 7.2 percent; the 2018-2019 state change was 1.8 percent. The 2009-2019 compound annual growth rate for Logan real GDP was 4.3 percent; the compound annual growth rate for the state was 1.4 percent.

## Industry Composition

Goods- and services-producing industries and government comprise total GDP. Industry statistics reflect the value of goods and services produced by each of those industries located in Logan. In 2019, goods-producing industries produced the largest portion of GDP, while services-producing industries and government produced the second and third largest portion of GDP, respectively.
