Personal income last published on November 16, 2021.

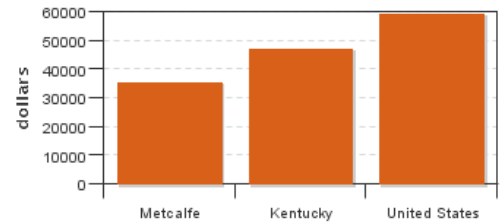
Metcalfe is one of 120 counties in Kentucky. It is part of the Glasgow, KY Micropolitan Statistical Area. Its 2020 population of 10,058 ranked 99th in the state.

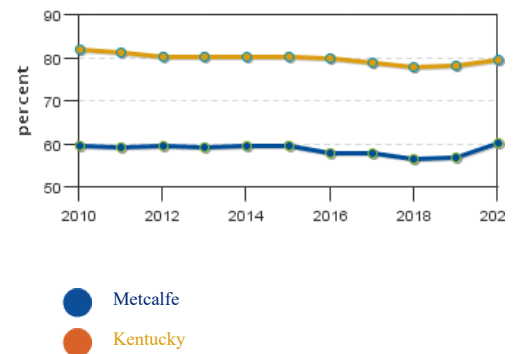
Per Capita Personal Income

In 2020, Metcalfe had a per capita personal income (PCPI) of \$35,804. This PCPI ranked 103rd in the state and was 76 percent of the state average, \$47,339, and 60 percent of the national average, \$59,510. The 2020 PCPI reflected an increase of 12.0 percent from 2019. The 2019-2020 state change was 7.9 percent and the national change was 6.2 percent. In 2010, the PCPI of Metcalfe was \$24,339 and ranked 107th in the state. The 2010-2020 compound annual growth rate of PCPI was 3.9 percent. The compound annual growth rate for the state was 3.5 percent and for the nation was 3.9 percent.

Personal Income

In 2020, Metcalfe had a personal income of \$360,116*. This personal income ranked 101st in the state and accounted for 0.2 percent of the state total. In 2010, the personal income of Metcalfe was \$246,677* and ranked 107th in the state.

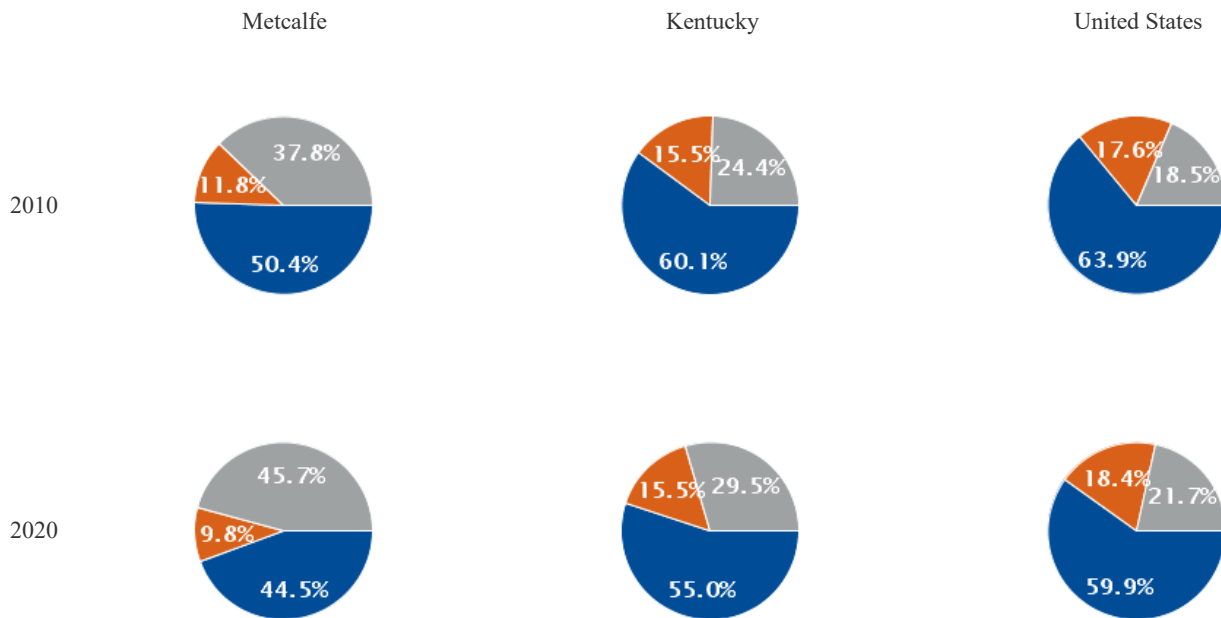
Components of Personal Income

Gross Domestic Product (GDP) by Local Area

In 2019, Metcalfe produced \$204,841 in **current-dollar total GDP***. This GDP ranked 104th in the state and accounted for 0.1 percent of the state total. In 2009, the total GDP of Metcalfe was \$143,990 and ranked 107th in the state.

In 2019, Metcalfe real GDP grew 5.8 percent; the 2018-2019 state change was 1.8 percent. The 2009-2019 compound annual growth rate for Metcalfe real GDP was 1.7 percent; the compound annual growth rate for the state was 1.4 percent.

Industry Composition

Goods- and services-producing industries and government comprise total GDP. Industry statistics reflect the value of goods and services produced by each of those industries located in Metcalfe. In 2019, services-producing industries produced the largest portion of GDP, while goods-producing industries and government produced the second and third largest portion of GDP, respectively.
