As part of our curricular transition to the 2016 criteria, we substantially revised our programs and eliminated concentrations. As part of this change, the environmental health faculty branched into a new degree program. Thus, we can no longer count these faculty as primary faculty, though they do continue to support our programs by offering the courses formerly required by the concentration. Per University policy, students were all given the opportunity to remain in their existing program of study (POS) or transition to the new POS. Most MPH students opted to transition to the new POS, with the exception of students graduating in 2017 and three generalist students who will graduate in 2018. Similarly, the BSPH students have transitioned to the new POS or have/will graduate in 2017.
