Chair Milliken read his typed statement regarding President Caboni's evaluation:

The WKU Board of Regents recently completed our annual evaluation of President Caboni with 100% participation among Regents. Throughout his tenure as President and accelerating during the past year, President Caboni has proven to be an effective leader with a remarkable ability to advance our university, create stability, and promote an overall culture of excellence and innovation. The Board continues to confidently support President Caboni's leadership and forward-looking vision for Western Kentucky University.

President Caboni's stewardship has helped WKU to make significant and rapid progress toward achieving the ambitious goals outlined in the university's 10-year Strategic Plan. His dedication to our institution's mission and thoughtful approach to challenges have been instrumental in driving transformative improvements in student success, academic excellence, and WKU's influence across our broader region. These efforts have not only enhanced WKU's current standing but have also solidified a robust foundation for future growth and success.

While the evaluation period focused on the previous academic year, WKU's positive momentum has certainly continued into this fall semester with notable achievements already occurring in the first half of the 23-24 academic year including:

- The first increase in overall degree-seeking enrollment in 13 years;
- The highest first-to-second year student retention in recorded university history;
- The commencement of construction on WKU's long-awaited new Gordon Ford College of Business building; and
- Commitments of more than \$92.9 million for the WKU Opportunity fund, which exceed President Caboni's original \$50 million goal by nearly \$43 million, 4 years ahead of the planned conclusion date.

The Board of Regents' review of President Caboni's performance makes clear that, because of the difficult work undertaken and the success of those endeavors, WKU is better positioned for the future under his leadership. We look forward to celebrating WKU's future successes as the university continues *Climbing to Greater Heights*.
