Update on current year budget – shared slides of 1<sup>st</sup> quarter results plus update on 10% charge on overhead of revenue dependent units.

Discussed net tuition revenue – WKU made strategic decision to focus on net tuition revenue (rather than head count). Net tuition revenue has increased \$3.2 mil over the past year, partially due to our scholarship model starting to work.

State appropriation is up (direct result from budget session from legislature last fiscal year). Extramurally funded grants up 10% over prior year. Salary expenses are flat (while there is an increase in the fringe because of increased health insurance costs).

The benefits committee has been (and will continue to) work on ways to get better control of our insurance increases for next year. Likely going to have to look at plan adjustments (e.g., no penalty to an individual for not getting vaccinated right now, but maybe consider that – if you decide not to get them, you'll pay a higher premium or similar for annual physical).

10% administrative overhead charge for revenue dependent and auxiliary update – Still working on how this will be implemented if/when it is. Will probably do it, but not until next year at the earliest because there are lots of questions around how you charge it, who will get charged, so many discussions and different ways of thinking.

Upcoming board of regents meeting – there is a committee meeting and then full board meeting. This can be confusing because some committee meetings will repeat on the agenda when they show up at full board.

Very minimal academic affairs items. A substantial portion of agenda is the external audit, including letter to management about things they didn't find.

Spiller reiterated that Susan and her team are truly open to conversations, happy to go over items in budget.

One-time payments are summarized in one report rather than quarterly, so that will be a small budget timing shift. Now that we have it tracked this way, we can start looking at year-over-year to see if we're having an increase in one-time payments (are there more adjuncts being used, etc.).

The board is reviewing and working on a change to the bylaws but haven't fully finalized that. This would include a change of name from Budget & Finance Committee to the Budget, Finance, and Audit Committee.

Spiller followed up with President about merit raise goal that he voiced in last Senate meeting. Spiller is hearing from B&F and industry experts that a 2% raise pool isn't enough to do merit raises in a meaningful way. We wouldn't have enough for much of a spread/difference.

#### 2. Provost, Robert "Bud" Fischer

VSIP comes to an end today and everyone will know by 11/1.

BEC made recommendation to President for 2% raise, approved and implemented.

ESE transitions are being worked on including centralized marketing and CRM.

Roughly 1,300 people on campus tomorrow (Friday 10/25) for Preview Day.

Calendar for next year was asked about and initial recommendations were handed to Provost today about possible changes. He will review and move on to the President.

Provost will go on tour again this year. He went to 31 departments last year and will be glad to visit departments again and answer any questions. He plans to be out and about in the spring.

## 3. SGA President, Sam Kurtz

Noted the loss of a student yesterday, SGA Health & Wellbeing Committee is exploring ways to better support students.

~150 participants at the breast cancer walk.

The SGA legislative cycle is underway which has included renewing veterans day 5K. All passed legislation can be found on SGA website.

Working on efforts to support civic engagement (voter registration pamphlets, school supplies were delivered to Jennings Creek) – lots of good events coming up.
